

No Other Way

Now when they heard this they were cut to the heart, and said to Peter and the rest of the apostles, ""Brothers, what shall we do?" And Peter said to them, ""Repent and be baptized every one of you in the Name of Jesus Christ for the forgiveness of your sins, and you will receive the gift of the Holy Spirit. For the promise is for you and for your children and for all who are far off, everyone whom the Lord our God calls to Himself." - Acts 2:37-39

Have you ever heard a statement like this?: "Although I am not a follower of any organized religion, I do believe in a supreme being. My faith says that a loving, Supreme Being will take a person to heaven if they lead a moral life and are sincere in their faith."

A Maryland dentist, Edward Gamson, can readily explain to people like this just how wrong they are. Here's Dr. Gamson's story. Recently, he used 375,000 frequent flyer miles to reserve first-class seats for himself and a friend as they traveled to a conference in Portugal. As long as they were that far, they thought they would pay a quick visit to and see the sights in Granada, Spain. The doctor made it across the Atlantic and switched planes in London. Twenty minutes into his next flight he noticed their British Airways jet was headed west and not south. When Gamson asked the flight attendant, "Why are we headed west to go to Spain?" he was told, "Spain? We're going to the West Indies." It was true. The British ticket agent had booked him on a trip to **Grenada** in the Caribbean and not **Granada** in Spain. Since Dr. Gamson's e-tickets didn't have the airport code or the duration of the flight, he ended up going in the wrong direction and to the wrong destination.

The ticket agent's mistake of one letter had made a major difference in the dentist's plans. Not only did he not get his vacation in Spain, he almost missed his conference, and the airline has refused to give him a refund on their mistake. Now here's the point: when Gamson got on that plane, he sincerely -- but wrongly -- believed he was headed for Spain. Even though the dentist was absolutely certain in his beliefs, his sincerity was not able to take him to where he wanted to go. Even more, Gamson found out it does make a difference what plane you get on. That's because, no matter how you might wish it to be otherwise, not all planes are going to take you to Granada.

Taking that information and applying it to our eternal destiny, we can say this: not all beliefs, even those that are held by a good and sincere person, are going to take that individual to heaven. Salvation reality says if someone wants to be forgiven of their sins and be adopted into the family of faith, that person has to have a right faith. On Pentecost, Peter accurately described this right faith when he said, "Repent and be baptized every one of you in the Name of Jesus Christ for the forgiveness of your sins and you will receive the gift of the Holy Spirit."

Lower Your Taxes with Qualified Charitable Distributions

I've included a helpful article from fidelity.com that explains how people 70 ½ or older can donate to their charity (or church) of their choice directly from the IRA. This will count toward the mandatory minimum distribution but doesn't count toward taxable income. That means you can continue to give to Good Shepherd or other charities you support but pay with pre-tax income, not post-tax income. At least I think that is what it means. Please read the article and talk with your tax consultant to learn how to do this.

Have you heard about qualified charitable distributions (QCDs)?

When planning your IRA withdrawal strategy, you may want to consider making charitable donations through a QCD.

A QCD is a direct transfer of funds from your IRA custodian, payable to a qualified charity. QCDs can be counted toward satisfying your required minimum distributions (RMDs) for the year, as long as certain rules are met.

In addition to the benefits of giving to charity, a QCD excludes the amount donated from taxable income, which is unlike regular withdrawals from an IRA. Keeping your taxable income lower may reduce the impact to certain tax credits and deductions, including Social Security and Medicare.

Also, QCDs don't require that you itemize, which due to the recent tax law changes, means you may decide to take advantage of the higher standard deduction, but still use a QCD for charitable giving.

Can I make a QCD? - While many IRAs are eligible for QCDs—Traditional, Rollover, Inherited, SEP (inactive plans only), and SIMPLE (inactive plans only)*—there are requirements:

- You must be 70½ or older to be eligible to make a QCD.
- QCDs are limited to the amount that would otherwise be taxed as ordinary income. This excludes non-deductible contributions.
- The maximum annual amount that can qualify for a QCD is \$100,000. This applies to the sum of QCDs made to one or more charities in a calendar year. (If, however, you file taxes jointly, your spouse can also make a QCD from his or her own IRA within the same tax year for up to \$100,000.)
- For a QCD to count towards your current year's RMD, the funds must come out of your IRA by your RMD deadline, generally December 31.
- Contributing to an IRA may result in a reduction of the QCD amount you can deduct. (The aggregate amount of deductible IRA contributions you make to your IRA after you turn 70 1/2 will reduce the amount of the QCD that is not includible in your gross income.)

Any amount donated above your RMD does not count toward satisfying a future year's RMD. Funds distributed directly to you, the IRA owner, and which you then give to charity do not qualify as a QCD.

Under certain circumstances, a QCD may be made from a Roth IRA. Roth IRAs are not subject to RMDs during your lifetime, and distributions are generally tax-free. Consult a tax advisor to determine if making a QCD from a Roth is appropriate for your situation.

What kind of charities qualify? - The charity must be a 501(c)(3) organization, eligible to receive tax-deductible contributions.

Tax reporting - A QCD is reported as a normal distribution on IRS Form 1099-R for any non-Inherited IRAs. For Inherited IRAs or Inherited Roth IRAs, the QCD will be reported as a death distribution. Itemization is not required to make a QCD. While the QCD amount is not taxed, you may not then claim the distribution as a charitable tax deduction.

A QCD is not subject to withholding. State tax rules may vary, so for guidance, consult a tax advisor.

When making a QCD, you must receive the same type of acknowledgement of the donation that you would need to claim a deduction for a charitable contribution. A tax advisor can help you determine if both your IRA and charity qualify for QCDs.


LWML


In All Things



Eight youth from our congregation have just returned home from Houston, Texas where they attended our synod's National Youth Gathering. There they gathered with almost 20,000 other teenagers to be strengthened in their faith and equipped to face the challenges of this world knowing that Christ is in all things. This gathering's theme was 'In All Things' based on Colossians 1:15-20. The Gathering was a positive experience for all who attended. Relationships were strengthened. We worshiped our Savior each day. One morning we joined with sister congregation Resurrection Lutheran Church in Houston to learn more about their ministries and projects and got to lend a helping hand. We spent a lot of hours looking at God's story of all things, deepening our faith as we unpacked a lot of different ways that Christ is in all things. From Bible studies, topical sessions, servant events, mass events, and many onsite resources, there were so many opportunities and ways to grow in our walk with Jesus. Some of the key points we focused on were 1) Jesus doesn't just create in the beginning, He is creating in all things, 2) Jesus doesn't just reconcile me to God, He is reconciling all things, and 3) Jesus doesn't just reign over some things, He is reigning over all things. As we dug further into our theme verses, we discovered how Christ is creating, cleansing, redeeming, reconciling, dwelling, reigning, transforming, and returning to restore all things. The big takeaways from our daily mass events were 1) Jesus is for you, for your highs, for your lows...in all things, 2) Sin is a middle word, grace is a final word, 3) Jesus takes our sins and in exchange gives us His perfection, 4) Jesus makes strong and beautiful things out of broken things, and 5) Jesus is working in all things so that you can be absolutely certain that you are a child of God. What a gift it was for these teenagers to experience God in this way through the Gathering. Thank you to all those who supported us with your gifts of prayer, encouragement, time, and finances. The 2025 LCMS Gathering will be held in New Orleans.
